- 2. For fire service connections, a vicinity map, site plan and utility plan showing the fire line and size of fire line, private fire hydrants on site, if any and risers to building (s) if building is sprinkled, as well as desired location will be required.**

3. **An initial application fee of \$500.00** is required for engineering and other related expense associated with preparing a design and cost estimate for each project.

PLEASE NOTE: The application fee will be applied as a prepayment to the line extension agreement or fire service connection if an agreement is executed with the Company within twelve (12) months from the date of the application: otherwise the application fee shall be non-refundable.

4. Please have the owner complete and return the enclosed **WATER SERVICE FACILITIES AGREEMENT** along with the other information requested herein.
5. A letter from the appropriate local fire department indication their concurrence with your plan or listing there water service requirements for fire protection for your project.
6. Location of the fire hydrants for private developments such as Subdivisions, Apartment projects, Commercial buildings, etc. shall be determined by local fire protection district. It shall be customer's responsibility to have the fire district provide Company with a copy of their design criteria for the project for which application for water service is being made.

AUTOMATIC FIRE SPRINKLER WATER CONNECTIONS AND PRIVATE FIRE HYDRANT INSTALLATION

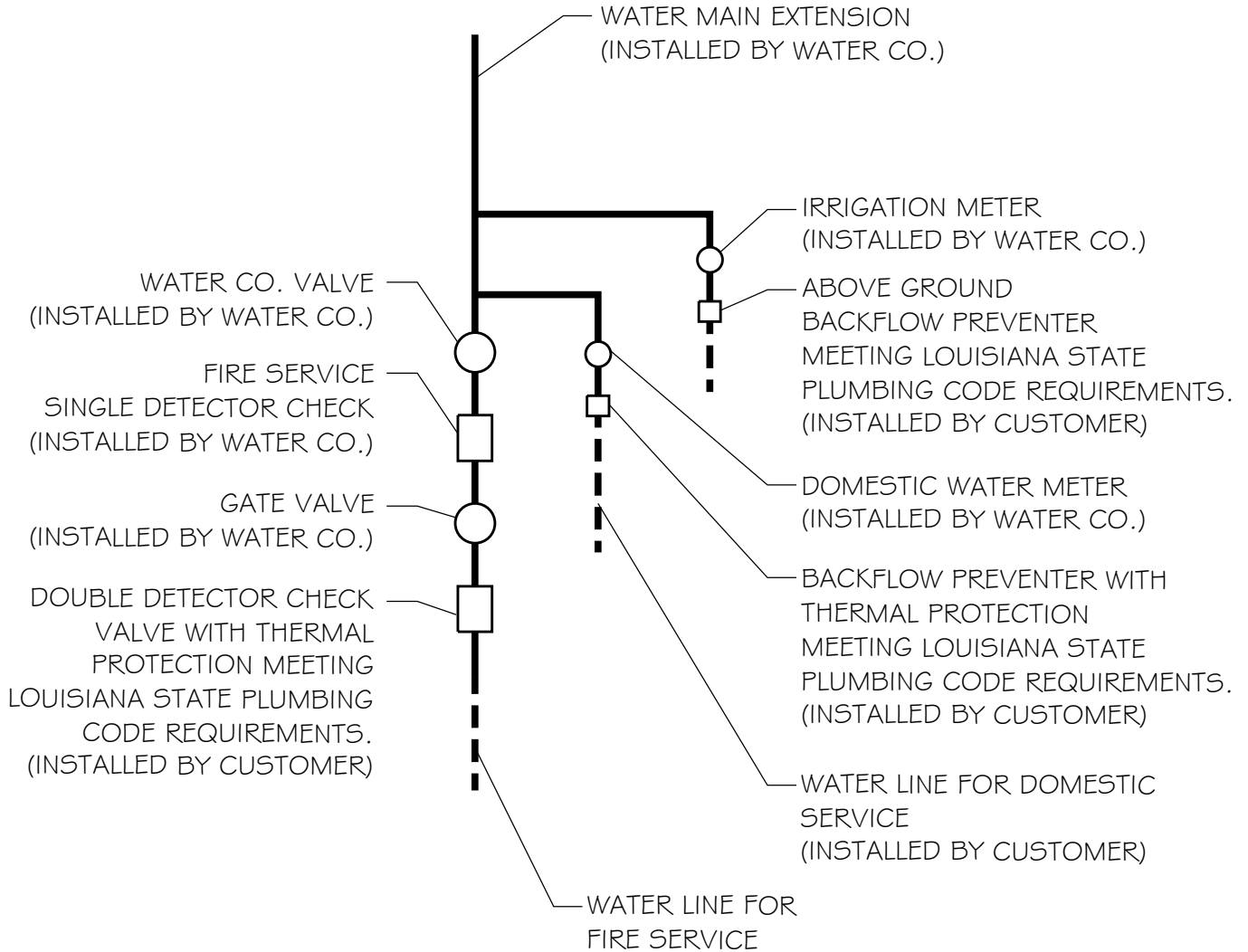
The Baton Rouge Water Company upon receipt of fire sprinkler application form, \$500.00 application fee and utility plan (plan to include riser/s to building if sprinkled, private fire hydrant/s and their location, size fire line and desired location of fire sprinkler meter, domestic, irrigation meter) will obtain a cost estimate for installation of fire sprinkler meter. A fire sprinkler/private fire hydrant contract will be prepared and sent to the owner of the property prior to installation. Upon receipt of contract and payment, the Company will install (in a timely manner) at the Customer's property line a single detector check meter and a 5/8" company meter (to register any usage).

Domestic and irrigation meters will also be required to install a backflow preventer. Type of backflow prevention for domestic and irrigation meters will depend on type of commercial facility (see State Plumbing Code).

CROSS CONNECTION CONTROL: The equipment installed by the Company is used solely for Company purposed and does not include a backflow prevention assembly. The Customer is responsible for the installation, inspection, and maintenance of adequate cross connection control equipment immediately downstream of the Company's metering equipment to meet the requirements of all applicable state and local codes for water service including, but not limited to, the Louisiana State Plumbing Code and the Louisiana State Sanitary Code. Prior to initiating service, Customer will be required to forward certification, signed by a certified and licensed Louisiana Master Plumber who is a licensed Water Supply Protection Specialist, that they are in compliance with all applicable codes and will remain operable during all periods of service. The Customer agrees to test all cross connection equipment installed immediately downstream of the Company's meter in accordance with the schedule contained in the Plumbing Code, and agrees to submit evidence of such tests in a timely manner. Failure by Customer to provide timely evidence of such test will be cause for the Company to discontinue service to the Customer without further notice. Service to the Customer will not be restored until such time as acceptable evidence of compliance is provided by the Customer to the Company.

Service to the above meters will be turned on only after a good water sample is received for the Health Department and proper certification is received.

I do hereby certify that the undersigned is the Owner of the above referenced property and hereby grant The Baton Rouge Water Works Company all necessary rights and privileges to enter upon said property for the purpose of installing and/or constructing, maintaining, operating, repairing and/or removing all such water facilities (including mains, meters, back flow preventers, service lines, etc.) as are reasonably needed and are contemplated by the undersigned's request for water service for said premises. This agreement shall be subject to such facilities being located immediately adjacent to the street right-of-way, but not limited to any specific area along such right-of way. This permit shall continue to exist so long as water service for said premises is furnished through said facilities of The Baton Rouge Water Works Company, which is also granted the right to remove or replace such facilities in accordance with the service requirements of the said property or the cessation thereof, at which time the right is likewise given to completely remove all of such facilities and to enter upon said property for such purposes.

Grantor shall provide Grantee and area free from concrete & other utilities, and also agrees that this area will not be used for parking or a landscape area.
